**Payment agreement:** 1. 100 % of the monthly payment applies to purchase of the instrument being rented. 2. A \$10 late fee will be charged automatically for any payment that is not received within 5 days of the payment due date. 3. The monthly payment price includes a service agreement. 4. A 25% discount will be given on any remaining balance if the instrument is paid off before the end of the contract. 5. Rental term is not to exceed 36 months. 6. Payments are not refundable if instrument is returned early.

I, the lessee, agree: 1. I will notify Shining Light Music of any address, phone number or credit card changes. 2. Any repairs done on this instrument must be done by Shining Light Music. 3. Shining Light Music requires a police report in case of theft or loss in fire. 4. To allow Shining Light Music and its representatives to pick-up the instrument from the school, home or elsewhere, with or without the knowledge of the renter if the rental payments are not kept current. 5. If I fail to return the instrument, then I am responsible for all reasonable costs Shining Light Music incurs for the return of the instrument and/or agree to let Shining Light Music charge my credit card for rent due and/or the value of the instrument outfit minus the deposit and rent already paid to Shining Light Music. 6. This account can be forwarded to a collection agency, if the instrument is not returned and a balance is owed. 7. There is (a) no obligation to continue with the lease payments after the end of each rental period as set forth by this contract, (b) I can continue to use the instrument by making the next scheduled lease payment, (c) return the instrument to Shining Light Music., under previously specified conditions, in which case no further obligation will be incurred under the contract. 8. Rental credit is forfeited if continuous rental is not maintained. 9. I have no right to sell, sublease, mortgage, pawn, pledge, encumber, or otherwise dispose of the instrument. 10. Legal ownership of the instrument outfit will not pass to me until the outfit price is paid in full.

## Instrument Rent-To Own Agreement

**Instrument Usage** – The renter agrees to lease the instrument as provided herein and agrees that the instrument will be used by the student in conjunction with a school music program.

**Rental Payments** – Renter agrees to pay Shining Light Music in advance for the initial rental period which includes a monthly fee and sales tax.. Rental fees are non-refundable. All payments beyond the initial rental period are due on the same day each month. Payments will be processed via credit/debit card by Shining Light Music employees on the due date. If the credit card is declined, renters will automatically be charged a \$10.00 late fee if their account isn't current within 5 days of the due date. Payments will be applied first to late fees then to current payments. Monthly payments will be applied 100% toward the purchase price of the instrument.

**Late Charge** – A late charge of \$10.00 per month is charged on any payment that is more than 5 days past its due date.

**Default** – Should the renter default on any monthly payment, Shining Light Music may assume that the renter does not wish to continue the trial purchase agreement, and may reclaim the instrument whenever found at school or elsewhere, with or without the knowledge of the renter. Should legal action be necessary to recover the instrument, the renter agrees to pay reasonable legal fees. Renter hereby directs any third party having custody or possession of the instrument, including school, to deliver the instrument to Shining Light Music on demand and agrees to hold Shining Light Music, the said third parties, school officials, and teachers harmless for such delivery. In the event the instrument is repossessed by Shining Light Music, renter shall, in addition to the cost of collection and instrument damage, pay all amounts due under the contract from the date hereof until recovery of the instrument by Shining Light Music. There will be an automatic collection fee of \$35.00 assessed at the time the account is turned over to collection. If the renter fails to make the monthly payments on the date specified on the contract, the renter must return the instrument immediately to Shining Light Music.

**Exchanges** – Shining Light Music will take any principle already paid on the previous rental instrument and apply it toward the purchase of a new or step-up instrument. Contracts must run concurrently, and any step-ups or exchanges must occur at the time the original instrument is returned. Shining Light Music does not offer store credits for rent paid on returned instruments.

**Manufacturer's Warranty** – In the event an instrument is covered by a manufacturer's warranty at the time that renter assumes ownership of the instrument, Shining Light Music shall pass the warranty on to the renter. Most pre-rented instruments are outside of a manufacturer's warranty.

## Service Agreement

**Service** – All adjustments and repairs will be made to keep the instrument in proper playing condition. Work must be performed by Shining Light Music technicians.

**Repair** – In case of accidental damage or regular maintenance the instrument will be restored to good playing condition. Minor case repairs, such as latches and hinges, etc., are covered. Parts replaced due to breakage must be replaced with like brand parts.

**Coverage does not include** – Replacement of expendable accessories such as reeds, strings, lyres, cleaning equipment, drum heads, drum sticks, removal of minor dents that do not affect playing quality, restoration of finishes, damage done by unskilled persons attempting repairs, or any malicious damage or destruction. All repairs, parts, and replacement must be handled by Shining Light Music. No reimbursements will be made for service or parts procured from other sources. Loss by fire or theft is not covered by this service agreement; renter is responsible for loss of instrument and is liable for full payment in this event. Service agreement does not cover neglect or abuse inflicted by force intentionally or unintentionally.
